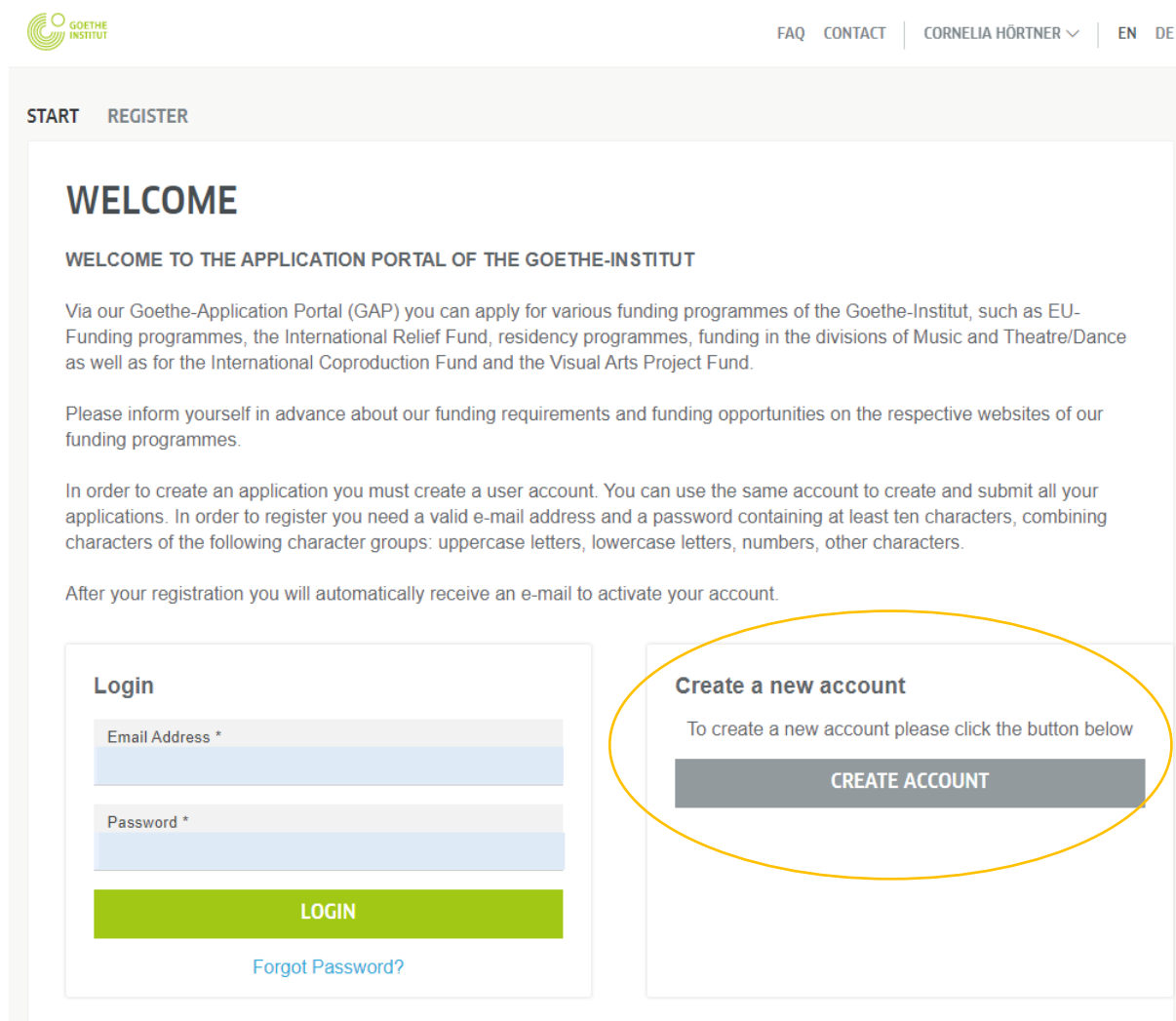

WELCOME TO THE APPLICATION PORTAL OF THE GOETHE-INSTITUT

Via our Goethe-Application Portal (GAP) you can apply for various funding programmes of the Goethe-Institut, such as EU-Funding programmes, the International Relief Fund, residency programmes, funding in the divisions of Music and Theatre/Dance as well as for the International Coproduction Fund and the Visual Arts Project Fund.

About the Goethe-Institut

The Goethe-Institut (GI) is the Federal Republic of Germany's worldwide cultural institute, promoting German language abroad and cultivating international cultural cooperation. Together with the previous partner *platform*, in 2018 the GI initiated the integrative creative industry hub called *takween*: a platform to support entrepreneurship within the creative industries in Jordan through qualification, exchange and networking as well as mentoring and experimenting. The focus of *takween* is on the design sector in Jordan including architecture, graphic and product design, handcraft, fashion design and interior design. Design as one of the clusters of the creative industries has strong ties to other clusters such as music, gaming, media art etc.

Context

The COVID-19 pandemic has put businesses and livelihoods of many designers and creative entrepreneurs at risk. In response to this situation, the Goethe-Institut Jordan, within the framework of *takween*, is planning to implement an accelerator program for start-ups in the field of design in Jordan to enhance their expertise as well as resilience and responsiveness in a time of profound challenges. Hence, the program searches for a ground between business scaling and building a sustainable business model. Further goals of the program include the personal growth as founders as well as the building of networks and community.

The *takween* Accelerator Program is intended to support up to 15 design start-ups in the cultural and creative industries sector in Jordan, whose sources of income have been severely affected by the pandemic.

Over the period of 2.5 months, the selected start-ups will receive a grant of up to 5,000.00 EUR to be spent during the program and participate in intensive training and mentoring sessions to strengthen their skills to be able to scale up and accelerate their business development, to enhance their resilience, to overcome challenges in a sustainable way, and to improve their prospects for employment and income within the CCIs in Jordan.

Program Time Frame: August 15– October 31, 2021
Number of Participants: Up to 15 start-ups
Number of Hours: A maximum of 240 hours

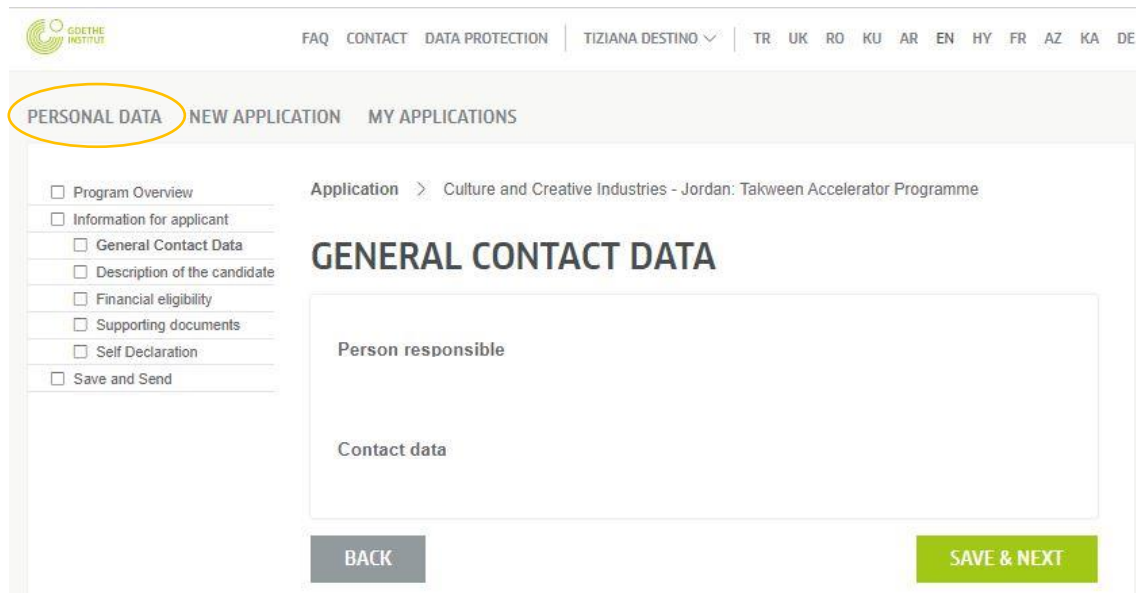

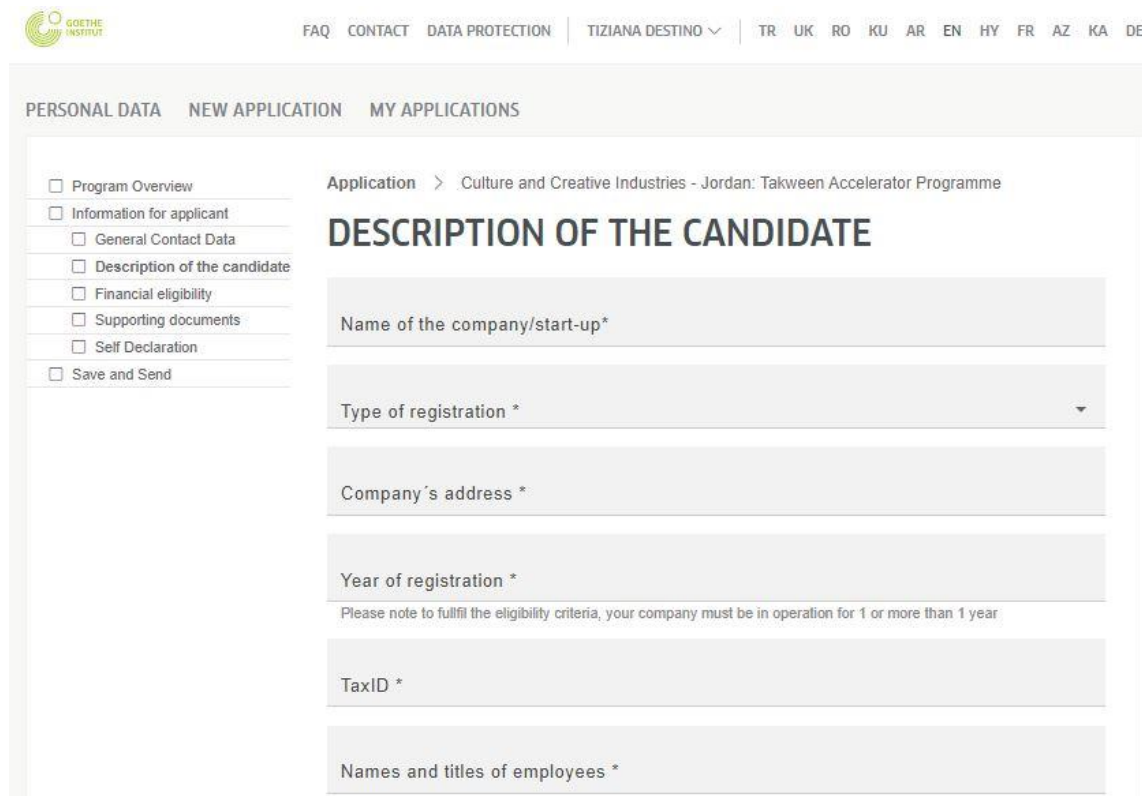

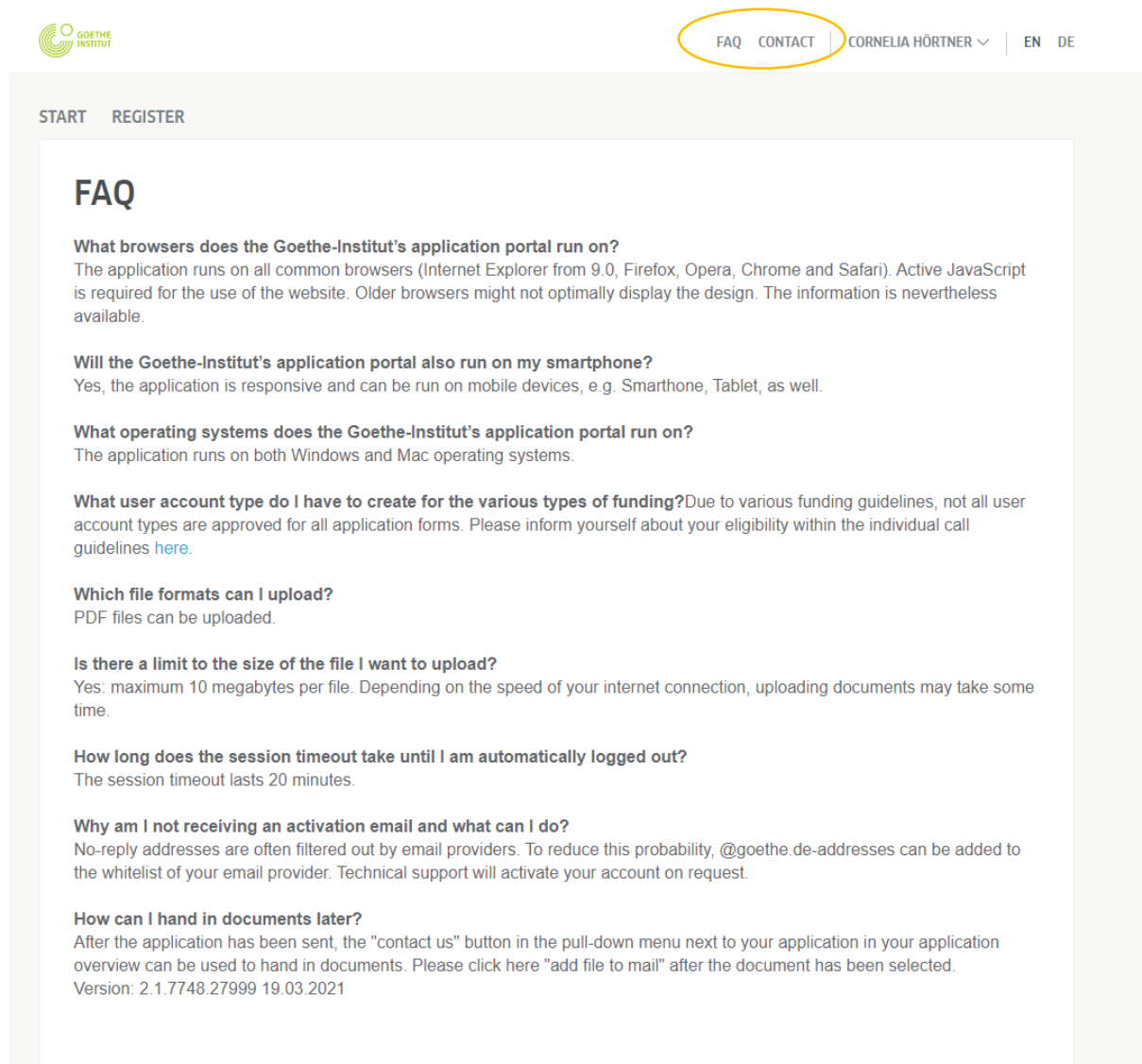

What browsers does the Goethe-Institut's application portal run on?
The application runs on all common browsers (Internet Explorer from 9.0, Firefox, Opera, Chrome and Safari). Active JavaScript is required for the use of the website. Older browsers might not optimally display the design. The information is nevertheless available.

Will the Goethe-Institut's application portal also run on my smartphone?
Yes, the application is responsive and can be run on mobile devices, e.g. Smartphone, Tablet, as well.

What operating systems does the Goethe-Institut's application portal run on?
The application runs on both Windows and Mac operating systems.

What user account type do I have to create for the various types of funding? Due to various funding guidelines, not all user account types are approved for all application forms. Please inform yourself about your eligibility within the individual call guidelines [here](#).

Which file formats can I upload?
PDF files can be uploaded.

Is there a limit to the size of the file I want to upload?
Yes: maximum 10 megabytes per file. Depending on the speed of your internet connection, uploading documents may take some time.
